

## CONTEST TERMS AND CONDITIONS

These Contest Terms And Conditions ("**Terms and Conditions**") govern your participation in the "Bigg Boss Marathi Question Contest" (the "**Contest**") conducted by Viacom18 Media Private Limited ("Company" or "we") on the website [www.Facebook.com](http://www.Facebook.com) ("**Facebook**") through its Facebook page viz. <https://www.facebook.com/ColorsMarathi> ("**Page**") for the promotion of its newly launched show "Bigg Boss Marathi" ("Program") telecast on the television channel viz. Colors Marathi ("Channel") and being produced by the Company through a third party production house ("**Production House**"). These Terms and Conditions apply to all users ("You/Participant(s)") who intend to participate in the Contest. Your participation in the Contest constitutes your agreement to follow and be bound by these Terms and Conditions without modification, and all other operating rules, policies and procedures that may be published from time to time by the Company. If you do not agree to these Terms and Conditions, you are advised not to participate in the Contest. Please be advised if you choose to continue to participate in the Contest, it shall be deemed that you have accepted the Terms and Conditions. The Terms and Conditions are personal to You, and are not assignable, transferable or sub-licensable by You.

### (I) PARTICIPANT'S ELIGIBILITY

A. The Contest is open only to the following:

- i. legal residents of India ("**Territory**")
- ii. Above eighteen years of age
- iii. have a valid Facebook account.

B. Participants should state all the required information, which has been asked from them including but not limited to the details required by Facebook. Any submission which is incomplete/ not fulfilled as per the terms of this Terms and Conditions and/or any terms and conditions laid on the Page and/or stipulated by Facebook shall be considered invalid for the purpose of the Contest.

C. The Contest is not open to the permanent and/or contract employees and directors of the Company, its parent, subsidiary and affiliated companies, advertising and promotion agencies (collectively, "**Viacom18 Entities/Company Entities**") and each of their immediate family members are not eligible to enter the Contest.

### (II) CONTEST PROCEDURE

A. The Contest shall commence from May 14, 2018 and will end on July 22, 2018 ("**Contest Period**").

B. Every week during the Contest Period, between Monday to Thursday ("Weekly Contest Period"), the Channel shall post an invite on its Page asking the Participants to share with the Channel, a question that they would want to ask the host or the contestants of the Program ("**Submissions**"). However, the Company reserves the right to suspend such Contest and not post any such invite in any particular Week during the Contest Period in its sole discretion.

A 'Week' for the purpose of this Terms and Conditions shall mean 'Monday' to 'Sunday' of every week during the Contest Period.

- C. Upon the Post being posted by the Company on the Page during the Weekly Contest period, Participants can participate in the Contest for that particular Week, by logging on to Facebook, by using their Facebook ID and password and shall further logon to the Page for making such Submissions. The Participants shall make the Submissions only via direct message on the Page along with the following details:
- Name of the Participant;
  - Name of the city where the Participant is located; and'
  - Valid contact number of the Participant.
- D. The Participants are cautioned not to share their Submissions on the public forum of the Page by replying to the post of the Company on the Page calling participation in the Contest. Such Submissions should be sent only through direct messaging.
- E. The Participants shall ensure that the Submissions submitted by them is in good taste, not obscene, vulgar, libelous, defamatory, insulting, annoying, hurting religious, community and nationality sentiments, or in any other way contrary to law, public morals or good taste. The Company/Channel/Production House reserves the right to disqualify any Submission if in its opinion such questions are in contravention of the aforesaid.
- F. The contact details submitted, as mentioned above, must be accurate and complete and are subject to proof upon request by the Company. Any inaccurate or incomplete information found in the Submissions will result in disqualification from entry into the Contest and the receipt of the Prize.
- G. Submissions shared by the Participants shall require a reasonable level of skill. It is clarified that only one Submission per Participant shall be considered during the Weekly Contest Period.
- H. The Submissions sent in the manner as provided hereinabove during a particular Week shall then be reviewed by the Channel and Production House and the Submissions that are most novel, unique, creative, witty, funny and/or distinct shall be selected in the manner as more particularly described in Clause III hereunder.
- I. The Submissions sent by the Participants are required to reach the Company on or before Thursday of every Weekly Contest Period during the Contest Period by 11:59 am ('**Due Date**'). Any Submission(s) received after the Due Date shall not be considered and only entries received before the Due Date shall be considered valid.
- J. The Company shall not be responsible in the event Submissions are not received in the manner provided herein, and also for technical error of any nature whatsoever that results in a Submission not being received.
- K. Submissions should state all the required information asked from the Participant(s) on the Page and/or in these Terms and Conditions. If the same is not complied with, then the Submissions will not be considered and will be disqualified.

- L. The Company shall not be responsible for any entries submitted but not received or recorded due to any reason whatsoever.
- M. There is no cost involved in for registration of the Contest. However, the network operator or the internet service provider shall charge such amount as deemed fit by them for the usage of their services for accessing the Page. The Company shall, in no circumstances, be responsible to reimburse any such cost incurred by the Participant on account of such participation in the Contest. Any dispute between the operator or service provider shall be settled directly between the Participant(s) and the service provider/operator.

### (III) SELECTION PROCESS

- A. After the Due Date of every Weekly Contest Period, Company will review all the eligible Submissions which will be scrutinized by the Company and the Production House. The Company will then select a maximum of 2 (two) eligible Submissions for each Weekly Contest Period ("**Winner/s**"). The Company reserves the right to increase the number of Winner/s in its discretion during any Week of the Contest Period.
- B. The Winners(s) will be selected by the Company, determined as per their sole discretion for each Submissions.
- C. In the event that the Company is of the opinion that none of the Submissions are eligible to be selected, then the Company may exercise its discretion not to select any Submissions and hence there will be no Winner/s.
- D. The Company will have the right to verify the authenticity of each Submissions uploaded as part of the Submissions and the Participants are required to comply with the requests of the Company to verify the authenticity of images submitted to the Company.
- E. The Company reserves the right to disqualify any Participant(s) from participating in the Contest without assigning any reason. The decision of the Company in this regard shall be final and binding upon the Participant(s).
- F. A Participant once chosen as a Winner will be entitled to only one Prize. Mere participation in the Contest does not entitle the Participants to win any prize.
- G. The Company/Production House shall contact the Winners directly by the end of a particular Week in which the Participant had participated in the Contest. The Winners shall be required to send his/her contact details and such other details ("**Personal Information**") as required by the Company in such manner as may be required by the Company. In the event the Winner(s) fail(s) to successfully inform the Company in the manner stated hereinabove, alternative Winner(s) will be selected.
- H. **Prize:** The Winner/s shall then be contacted by the Production House and subject to the availability of such Winner(s) on the day of shoot of the Program, the Winner/s shall be given an opportunity to ask the submitted question directly to the host or the contestant(s) of the Program via a telephonic conversation, during the shoot of the Program and such recording shall be a part of any of the weekend episode/s of the Program of that particular Week in

which the Winner/s had participated in the Contest. However, if due to certain unforeseeable circumstances the Company is unable to include such question in any of the weekend episode/s of that particular Week then the Company shall include such question in any of the subsequent weekend episode/s of the Program.

- I. The day and time of shoot of the Program is decided by the Company/Production House and is unchangeable except in certain unforeseen circumstances. Hence, if any Winner/s is unable on such day and time, the Company reserves the right to invalidate the Prize for such Winner/s and select another Winner/s. However, such dates are subject to change in the event of some unforeseeable events and the Company reserves the right to choose another date and time for use of the same which it shall communicate to the Winners.
- J. All decisions of the Company shall not be subject to any appeal of any nature whatsoever. Submissions in the Contest shall be construed that the Participant has waived his/her right to dispute any decision(s) made by Company.
- K. Each Participant consents to the use of information supplied by the Participants, to the extent possible under any applicable laws of India, in any media for further promotional, marketing and publicity purposes without any further payment or other compensation to the participant by the Company and its affiliates.
- L. The Winners shall not in any circumstances make any claims against the Company or the Viacom18 Entities arising out of or relating to any and all costs, injuries, losses or damages of any kind, including, without limitation due to any technical faults or directly or indirectly, to the winner's participation or non-participation in the Contest or any related activity. If the Winner is found to be ineligible, or if he or she has not complied with these terms and conditions, the corresponding Submission will not be considered further.

If the Company so elects, Winner will be required to submit to a confidential background check to confirm eligibility and help ensure that the Winner will not bring Viacom18 Entities into public disrepute, contempt, scandal or ridicule or reflect unfavourably on the Company as determined in their sole discretion.

#### **(IV) TERMS AND CONDITIONS FOR THE PRIZE**

- A. The Company reserves the right to change the Prize at any time at its discretion.
- B. The Prize cannot be transferred, negotiated, refunded or exchanged and only the Winner(s), and not any other person or agent, may claim the Prize.
- C. The Winner(s) must avail the Prize on the dates provided by the Company and such dates are final and not changeable. If the Winner(s) is unable to collect/avail it on such date, Company reserves the right to invalidate the Prize. However, the dates are subject to change in the event of some unforeseeable event not in the control of the Company and the Company reserves the right to choose another date for use of the same which it shall communicate to the Winners.

(V) LIMITATIONS OF LIABILITY: BY ENTERING THE CONTEST, EACH PARTICIPANT ACKNOWLEDGES AND AGREES THAT: (I) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR IN CONNECTION WITH THE CONTEST, OR ANY PRIZE AWARDED, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND (II) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED AND ASSOCIATED WITH ENTERING THE CONTEST (IF ANY), NOTWITHSTANDING THE FOREGOING, UNDER NO CIRCUMSTANCES WILL COMPANY AND/OR COMPANY ENTITIES BE LIABLE FOR ANY CONSEQUENTIAL, INDIRECT, SPECIAL PUNITIVE, OR INCIDENTAL DAMAGES OR LOST PROFITS, WHETHER DIRECT OR INDIRECT, ARISING IN ANY WAY WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE.

(VI) **OTHER TERMS**

A. Proprietary Rights in the Submissions: You hereby grant to the Company the non-exclusive, perpetual, royalty-free, worldwide license to use, copy, sublicense, adapt, transmit, distribute, publicly display, modify such Submissions. You represent and warrant that: (i) you own the Submissions posted by you for the Contest (ii) your Submissions does not violate the privacy rights, publicity rights, copyright rights, intellectual property rights, or any other rights of any person, and (iii) the posting of your Submissions for the Contest does not result in a breach of any contract between you and a third party. You agree to pay for all royalties, fees and any other monies owing any person by reason of any Submissions you post for the Contest.

B. Prohibited User Content. The following is a partial list of the kind of Submissions that is illegal or prohibited on the Page. The Company reserves the right to investigate and take appropriate legal action in its sole discretion against anyone who violates this provision, including without limitation, removing the offending Submissions from the Page on Facebook. Prohibited Submissions includes content that you should not host, display, upload, modify, publish, transmit, update or share including information that:

- Relates to personal or sensitive personal information about yourself or any third party;
- is obscene, patently offensive, or promotes racism, bigotry, hatred or physical harm of any kind against any group or individual;
- harasses or advocates harassment of another person;

- promotes information that you know is false or misleading or promotes illegal activities or conduct that is abusive, threatening, obscene, defamatory or libelous;
- exploits people in a sexual or violent manner;
- solicits personal information from anyone under 18;
- provides any telephone numbers, street addresses, last names, URLs or email addresses, including in your account profile;
- violates the copyright, trademark or other intellectual property rights of any other person;
- furthers or promotes any criminal activity or enterprise or provides instructional information about illegal activities such as making or buying illegal weapons, violating someone's privacy, or providing or creating computer viruses;
- solicits passwords or personal identifying information for commercial or unlawful purposes from other users; or

- involves commercial activities and/or sales without our prior written consent such as contests, sweepstakes, solicitation of donations, barter, advertising, or pyramid schemes;
- belongs to another person and to which the user does not have any right to;
- is grossly harmful, harassing, blasphemous defamatory, obscene, pornographic, paedophilic, libellous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, relating or encouraging money laundering or gambling, or otherwise unlawful in any manner whatever;
- harm minors in any way;
- infringes any patent, trademark, copyright or other proprietary rights;
- violates any law for the time being in force;
- impersonate another person;
- contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource;
- interfering with, disrupting, or creating an undue burden on the site or the networks or services connected to the Contest;
- threatens the unity, integrity, defence, security or sovereignty of India, friendly relations with foreign states, or public order or causes incitement to the commission of any cognisable offence or prevents investigation of any offence or is insulting any other nation.

**C. Representation and Warranty**

By posting the Submissions, you represent and warrant to the Company that you are aware that the Submissions shall be accessible by public at large and there is no obligation on the Company to keep the Submissions confidential;

You shall participate in the Contest in a manner consistent with any and all applicable laws and regulations.

Company may use the Submissions for such purpose as it deems fit, including informing any third party such as press or the local authorities for further investigation into the content of the Submissions that the Submissions is in compliance with all the terms and conditions of this Terms and Conditions;

**D. Your account information**

You agree that you (a) have provided true, accurate, current, and complete information to Facebook, and to the Company in connection with the Contest; and (b) will maintain and update this information to keep it true, accurate, current, and complete. We reserve the right to terminate your access to the Page in the event we learn or believe any information provided may be false, inaccurate, not current, or incomplete.

If any unauthorized person obtains access to your account or the Page as a result of any act or omission by you, you shall use your best efforts to ascertain the source and manner of acquisition and shall fully and promptly brief us. You shall otherwise cooperate and assist in any investigation relating to any such unauthorized access.

## E. Limitations

You agree to abide by all applicable local, state, national, and international laws and regulations in relation to the Contest, and not to act in any manner that is prohibited by the Terms and Conditions. - (e) provide any information, including but not limited to email addresses or telephone numbers of friends, if you do not own or have permission to use.

The Company may delete, edit, or reject the content at any time for any reason without notice to you. The Company will not be held liable for any damages of any kind, including, but not limited to, direct, indirect, incidental, punitive, and consequential damages (a) related to its use or rejection of any content posted by you; (b) arising from the use of the public posting areas of this Contest; and (c) related to your viewing of any content for the Contest that you may find offensive.

Although the Contest has been organized/ created in good faith, no representation is made as to the completeness or accuracy of the information it contains. The information contained on the Page/Terms and Conditions may be incomplete, may contain errors, or become out-of-date. The Company makes no commitment and expressly disclaims any duty to update any of its content. Company reserves the right to add, modify, or delete any information in the Terms and Conditions at any time.

## **G. Indemnification**

Except as provided below, the Company and its affiliates and licensors retain all right, title and interest in the Website and the Page ("VIACOM18 Intellectual Property"). You may not modify, publish, transmit, transfer or sell, reproduce, create derivative works from, distribute, perform, link, display, or in any way exploit the VIACOM18 Intellectual Property, in whole or in part, except as expressly permitted in these Terms and Conditions or with the prior written consent of the Company.



Recognizing the global nature of the Internet, you agree to comply with all applicable local rules and regulations regarding your online conduct. We make no representation that the content available at or through the Contest or any other program or service offered on or through the Contest is appropriate or available for use in other locations, and access to them from territories where the content may be illegal is prohibited.

**VI GENERAL TERMS:**

- a) The viewer(s) interested in participating in the Contest must be above the age of 18 years and a resident of India. The Participant(s) should not have criminal conviction or an arrangement or a contract that prevents the Participant(s) from participating in the Contest.
